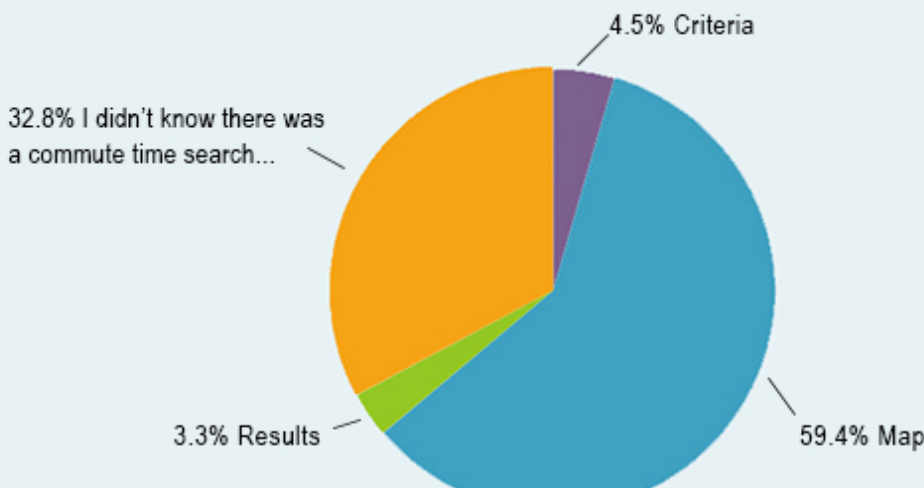

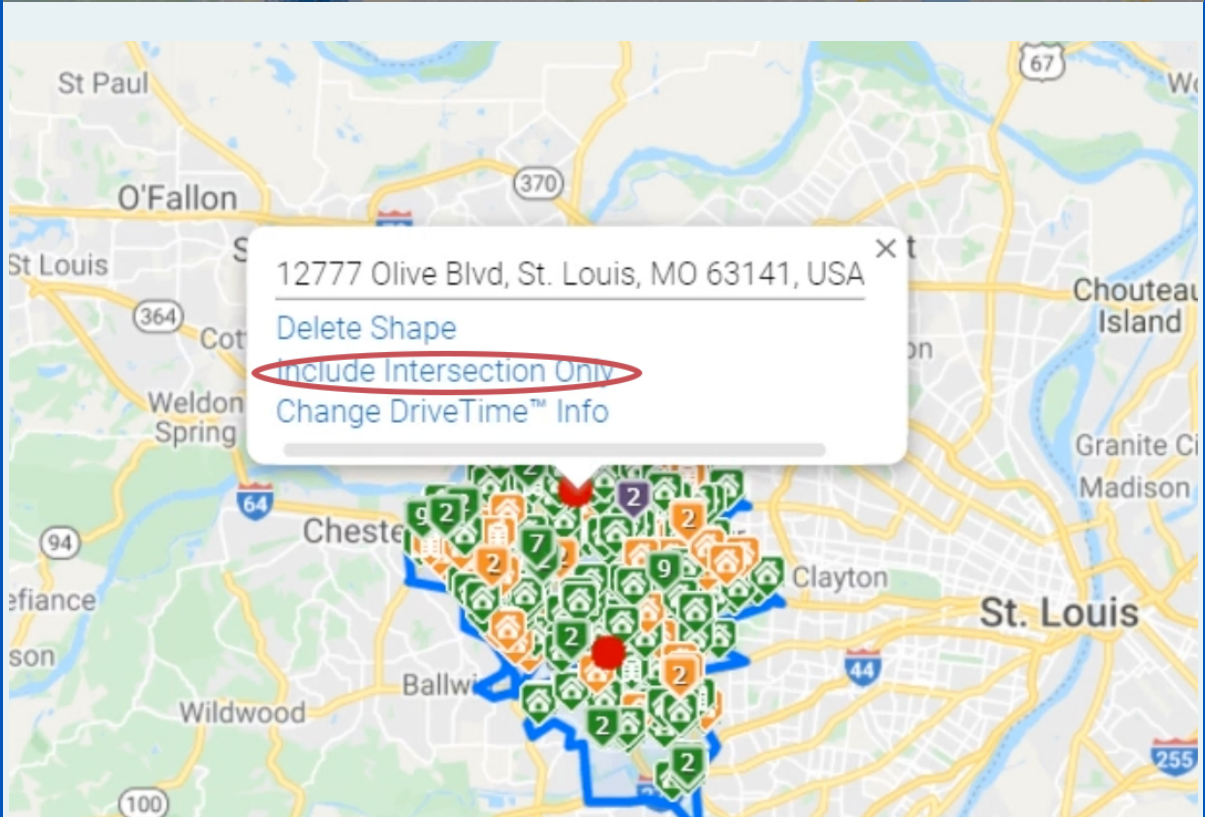
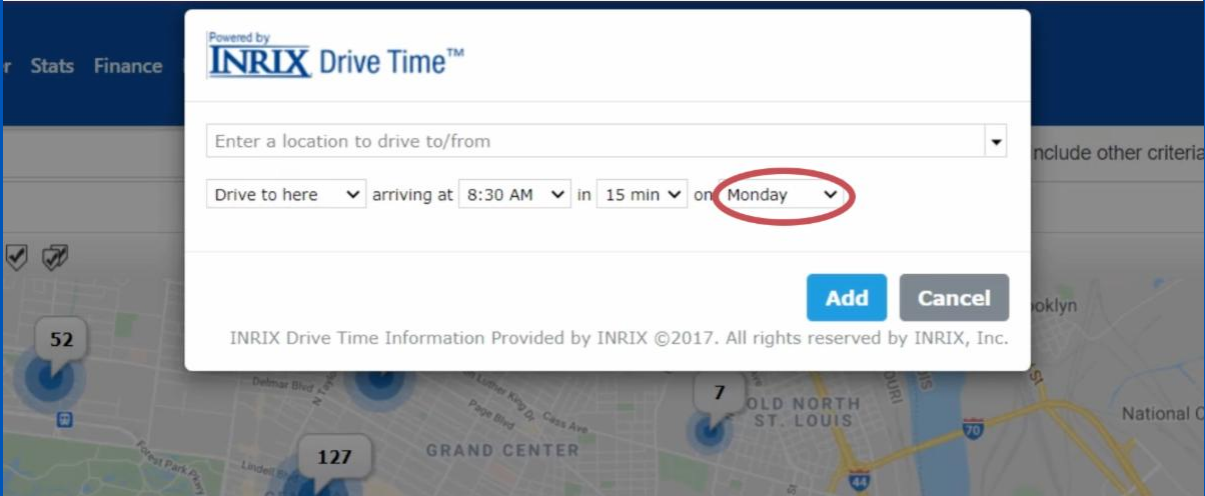
## Matrix Education Widget

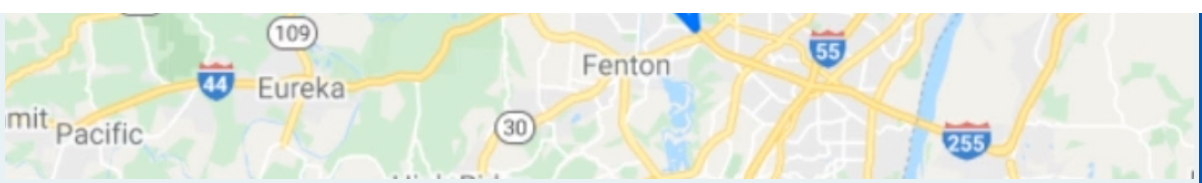

1. The commute time search in Matrix, called Inrix Drive Time™, is found on which search tab below?



As it turns out, many of our Members didn't know about the recently-updated commute time feature in Matrix X, and we are excited to share with you that there have been two significant upgrades made to the Inrix Drive Time™ feature. When searching for homes within a certain commute time, you can now add a day of the week to your search in order to hone in on specific commute times for clients who may have jobs that operate outside of the standard weekday 9-5. Additionally, you now have the capability to create multiple search radii for clients who need to consider multiple commute times when buying a home.
